Carriageway Post Treatment Ironworks

Impton Lane, Boxley



When we plan to carry out the work and how long it will take

This is to inform you that as part of the on-going maintenance and improvement of the highway network, Kent County Council will be carrying out post treatment works to the carriageway of **Impton Lane**, **Walderslade between the junctions of Walderslade Woods and Walderslade Woods (entire road)**.

These post treatment ironworks are programmed to start on the **28th November 2024** and should take **5** days to complete. These activities will be undertaken during a **working window** between the hours of **7am** and **7pm**.

This type of work can be affected by bad weather, so if it is not possible for us to carry it out at this time, we will arrange a new date and let you know via a letter drop to your home. We will also put up signs along the road before we start showing the date we plan to start work.

During these essential works it will be necessary to control the traffic with temporary signals (28th to 30th November) and then close the road (2nd and 3rd December) so that we can carry out the works safely for both the workforce and road users. There is no diversion route as such so the closure will be phased in stages to maintain residential access where possible and when safe.

What we plan to do

Following on from our road surface treatment earlier in the year we will now be returning to raise any ironwork and ensure that it is level with the new surface. The raising of ironwork requires completion after the new surface is laid, as undertaking this activity prior to surfacing can compromise the works and result in the gullies and manholes not being level with the new surface. Our works detailed in this notification will ensure that the ironwork is raised to the correct level and compliment the recent surfacing works.

How you can help

It is inevitable that residents and businesses near the works will experience some disruption, but we will try to keep these to a minimum. Any pavements will remain open at all times, but vehicle access to properties will need to be restricted for a short period while work is carried out in front of each property. If you have any particular access needs, please let the workforce on site know.

We need your help to make sure the work is done as quickly as possible and to the best possible quality.

If your vehicle is usually parked on the carriageway, please make sure you park it somewhere else away from the site whilst the works are carried out, so the road is clear for us to complete these works activities.
